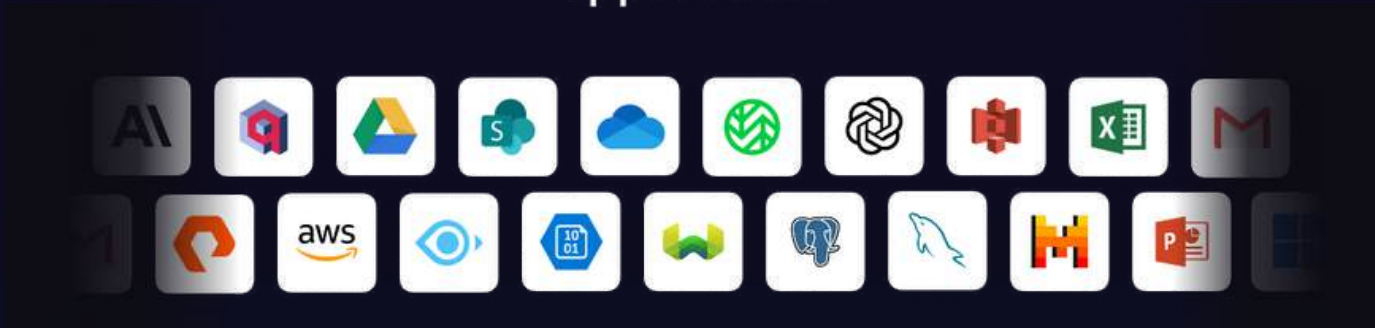

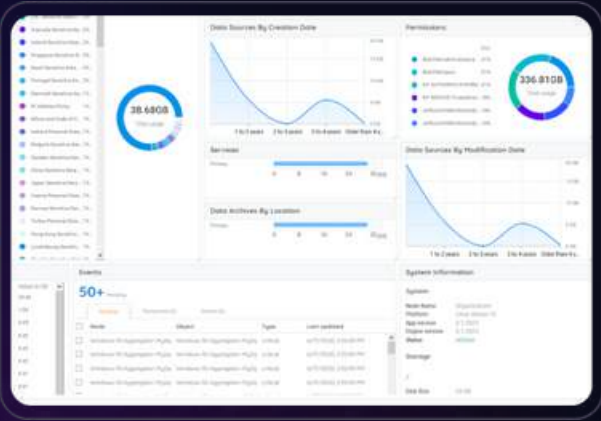
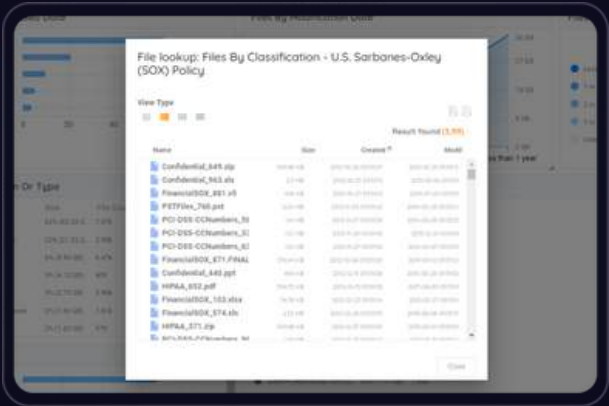


Intelligent Data Classification and Tagging

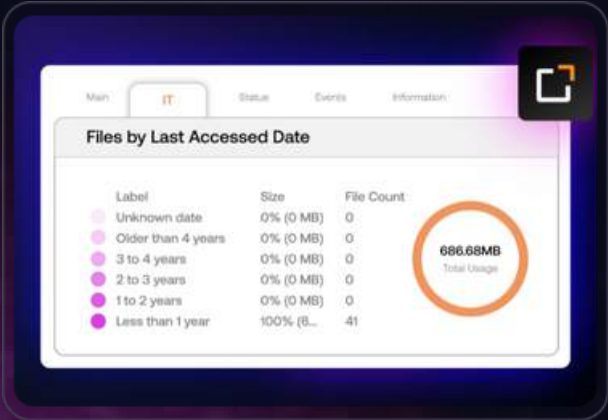
